

Information clause VIDEO MONITORING

In order to fulfill the information obligation under Article 13 section 1 and section 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Journal of Laws EU L.2016.119.1, amended by Journal of Laws EU.L.2018.127.2), hereinafter referred to as GDPR - in connection with the acquisition of your personal data, we inform that:

- The Data Controller of your personal data is "Rzeszów-Jasionka" Airport Ltd. with its registered office in Jasionka, address: Jasionka 942, (36-002), entered in the Register of Entrepreneurs of the District Court in Rzeszów kept by the 12th Commercial Division of the National Court Register under KRS number (National Court Register Number): 0000296055, REGON number: 180288180, NIP number (Tax Identification Number): 5170240616, e-mail: rzeszowairport@rzeszowairport.pl, tel: +48 17 852 00 81, +48 17 717 86 11.

- 3. Your personal data will be processed in order to ensure the protection and safety of employees and other persons on the monitored area of the Airport "Rzeszów-Jasionka" Ltd., to comply with applicable procedures, to control the quality of security, as well as to implement the provisions contained in the Act of 3 July 2002 Air Law, in the regulation of the Minister of Transport, Construction and Maritime Economy of 31 July 2012 on the National Civil Aviation Security Program, in the regulation of the Minister of Transport, Construction and Maritime Iconomy of 25 July 2013 on the National Quality Control Program for the protection of civil aviation.
- 4. The legal basis for your personal data processing is:
 - 1) Art. 6 section 1 letter c of GDPR (the processing is necessary to fulfill the legal obligations incumbent upon the Data Controller under applicable law).
 - 2) Art. 6 section 1 letter f of GDPR (the processing is necessary for purposes such as the possible need to refute or implement civil law claims arising from legitimate interests pursued by the Data Controller, such as protection of property and non-property rights).
- 5. You have the right to request access to your personal data, its rectification, deletion, or restriction of the processing, as well as the right to submit an objection against the processing and the right to oppose any further processing and the right to transfer the data.



- 6. You have the right to lodge a complaint with a supervisory authority, i.e. President of the Office for Personal Data Protection).
- 7. The provision of data is voluntary, but necessary to obtain permission to enter and move within the "Rzeszów Jasionka" Airport Ltd. If you do not provide the data, you will not obtain permission to enter the Airport.
- 8. The data provided by you will not be disclosed to third parties. The recipients of the data will be bodies and institutions authorized to obtain data on the basis of applicable law, e.g. Border Guard, Police, Civil Aviation Office. In addition, your personal data will be disclosed to authorized persons employed by the Data Controller on the basis of employment contracts or civil-law contracts.
- 9. Your personal data will not be subject to automated decision making, including profiling.
- 10. The Data Controller does not intend to transfer personal data to a third country or international organization.
- 11. Only image (without sound) is subject to the registration and storage of data on a medium.
- 12. Your personal data will be kept for a period of 30 days from the date of recording. If the recording is or may be used as evidence in proceedings conducted on the basis of the law, the date of its storage is extended until the final completion of the proceedings. After the expiry of the above-mentioned periods, the recordings containing personal data will be destroyed, unless otherwise provided for in the provisions of law.
- 13. The range of video monitoring in the "Rzeszow Jasionka" Airport Ltd. includes the internal area of the airport together with the terminal building, administrative and technical building, air transport routes, aprons, de-icing plates, gas station and the external area of the airport together with access roads, squares and parking lots, the area adjacent to the airport.
